Skyline Roofing's Commitment to Safety: Skyline considers safety to be a core value that shapes our behavior. Safety is an essential consideration in all business decisions and is a requirement in the performance of all job tasks. The following is an overview of our safety performance and comprehensive safety programs which should highlight our commitment to safety.

Written Safety Programs

All programs are administered through the full-time efforts of our Safety Manager.

Training

Employees are required to attend mandatory training which covers topics including:

- Fall Protection
- OSHA Jobsite Inspections
- OSHA Regulations
- OSHA 10 & 30 Hour
- Hazard Communication
- Personal Protective Equipment
- Fire Protection
- Hazard Identification
- Bloodborne Pathogen
- Rough Terrain Forklift
- Safety Meeting/Daily Checklist
- First Aid/CPR/AED

Weekly “Toolbox” Safety Talks are conducted by the foreman. General safety topics are reviewed, along with specific hazards pertaining to the job.

Monthly mandatory safety meetings are conducted by the Safety Manager with all personnel to review general and job specific safety Issues.

Inspections

Pre-Job Inspections: Sales, Project Managers, and Safety Manager pre-job inspection. Provide the required safety equipment and the proper procedures necessary to complete the proposed project.

Spot Check Inspections: Safety Manager regularly visits job sites to ensure safety precautions are being implemented.

Daily Inspections: Foreman perform daily job site checklists to ensure that crews are protected from hazards and are following safe work practices

Unannounced Inspections: Safety Manager conducts unannounced, OSHA-type safety inspections to ensure that the foremen and crews are utilizing safe work practices. Should violations exist, appropriate disciplinary action is implemented.

Accident Investigation

In the event of an accident, facts are gathered, reviewed and reported by the employee and foreman. Each accident is then investigated by Skyline’s Safety Manager. Hazardous conditions, if any, are corrected and/or eliminated.

OSHA Logs are maintained at the corporate office and filed electronically via OSHA’s Injury Tracking Application. Skyline’s incidence rates are provided below for your review. Incidence rates permit potential customers to compare Skyline’s safety performance to that of industry statistics.

Skyline also maintains hard copies of the written Hazard Communication Program and all Safety Data Sheets at the corporate office and can be provided at the request of the customer. Hazard communication training is provided on an annual basis during scheduled mandatory safety meetings and via toolbox safety talks.
